

# RhosGFX Commercial Use License Agreement

This Commercial Use License Agreement ("Agreement") is entered into between you ("Licensee") and RhosGFX ("Licensor"). By purchasing this Agreement, you agree to the terms and conditions contained herein.

#### 1. Grant of License

- i. Licensor grants Licensee a perpetual, non-exclusive, non-transferable, non-assignable license to use any RhosGFX icon pack purchased by Licensee (the "Materials") in both personal and commercial projects.
- ii. This license applies only to icon packs obtained from rhosgfx.itch.io (the "Source").
- iii. This license does not permit the resale, redistribution, or sublicensing of the Materials, whether in original or modified form.

## 2. When This License is Required

This license is only required if:

 You are including RhosGFX icons in UI packs, game kits, software, or other digital assets that are distributed or sold in a form where the icons are easily extractable.

You do not need this license if:

- You are using the icons in your own game, website, Discord server, logo, or graphic.
- You are hiring someone to use icons you own in your project.
- You are being hired to use icons your client owns.
- You are selling graphics (e.g. logos, promo images, gamepasses) where the icons are included but are not easily extractable.

### 3. Restrictions

- i. You may not resell, redistribute, sublicense, lend, rent, decompile, reverse-engineer, disassemble, or adapt the Materials except as explicitly permitted by this Agreement.
- ii. You may not use the Materials in any project or context that violates the laws of England & Wales, international law, or the jurisdiction in which you operate.

## 4. Intellectual Property

- i. The Materials are the sole intellectual property of RhosGFX and are protected by applicable copyright and intellectual property laws.
- ii. This Agreement does not grant you any ownership or intellectual property rights in the Materials.

## 5. Proof of License

- i. Your license is tied to the email used to create your itch.io account at the time of purchase.
- ii. If you lose access to your itch.io account or the associated email, you will need to purchase this license again.

## 6. Liability

- i. You are solely responsible for any materials or projects that incorporate the Materials.
- ii. RhosGFX shall not be held liable for any damages, direct or indirect, arising from misuse or unauthorized use of the Materials.
- iii. RhosGFX guarantees that the Materials will function as described for a period of 90 (ninety) days from the date of purchase. In the event of failure, RhosGFX will offer either a replacement or refund not exceeding the original license payment.

### 7. Termination

- i. RhosGFX reserves the right to terminate this Agreement if you fail to comply with its terms.
- ii. Upon termination, you must immediately cease all use of the Materials and destroy any copies in your possession.
- iii. Termination does not preclude RhosGFX from pursuing legal remedies for damages incurred by your breach of this Agreement.

# 8. Entire Agreement

This document constitutes the entire agreement between the parties and supersedes all prior understandings or agreements, whether written or verbal, relating to the subject matter herein.
